## The Year in Review

### Letter from Executive Director

*To all of you who aren't able to be here right now, soooooo sorry! Indian Summer has finally arrived in the North Woods, and although the nights are frosty, the days have been heating up into the mid 50's (or higher) for several days in a row. Coupled with a good deal of sunshine, and what were perhaps the countries very best fall color display, this October was one of the best on record—if enjoying the great northern outdoors is the goal. And it definitely is the goal of yours truly.*

*Early in the morning I get up, plod to the kitchen to start the coffee, and then light the fire that I set the night before. Within twenty minutes, the cabin is warm, and I can just look out the picture window at the sunrise without having to accomplish any more “waking up” tasks. This is the best time of the day for me because it allows me to quietly sit and reflect on how really blessed I am to be able to enjoy this place every day of the year. I know some of you are saying “I’ll bet he doesn’t sing this tune in mid-February”, but you would be wrong. There is great beauty in the earliest rays of light as they stream across a snow drift, and even when it’s 30° below outside, inside it is warm and toasty, and the light coming through that same picture window is warm on my face.*

*These early morning moments have also allowed me to think about where we are at as a Lake Association, and to evaluate our successful progress on the many initiatives we’ve set for the organization.*

### Our efforts to control Eurasian Water Milfoil

*Lately, I’ve been trying to wrap my mind around all of the data that I collected in doing the fall **Eurasian Water Milfoil (EWM) survey**. This survey is used to determine the number, size and shape of the “polygons” where EWM will be chemically treated next spring. As I’ve started to analyze all of the data collected, I’ve begun to understand just how subjective the final survey results can be. Our chemical treatments from last spring were very successful in removing EWM from the polygons that had been identified in the fall of 2009. But when I’ve added in the locations of new infestations that the Sentinels (Tomahawk Lake Association’s lake volunteer lake monitoring organization) have found, and the areas of new infestation that I found in my fall survey, I’ve realized that we are fighting an incredibly tenacious foe. The good news is that while there are quite a few new locations to treat next summer, we are better prepared to fight the battle than ever before. This past summer season we treated 82 acres with one form or another of 2, 4D aquatic herbicide. We will chemically treat less acreage in the*

### TLA Reduces Eurasian Water Milfoil Infestation by 78 percent in 2010

#### New EWM infestations identified by TLA Sentinels

The Tomahawk Lake Association (TLA) reported that the total acreage of Eurasian Water Milfoil (EWM) treated in the spring of 2010 was reduced by 78 percent, or roughly 62 acres.

While a successful result, a number of new EWM infestation sites were discovered by the Sentinel Lake Monitoring Group in June and July. Eurasian Water Milfoil is an aquatic plant native to Europe and Asia that reproduces rapidly and has the potential to choke much of the shallow areas of a lake and adversely affect wildlife. It was first discovered on Tomahawk Lake in the fall of 2004 and, at the beginning of 2010, covered nearly 82 acres within the lake.

## Fundraising Changes for 2011: Lake Property Owners Asked to Contribute “Fair Share”

Every year, the TLA works hard to keep EWM under control—and this year’s results are a tremendous success. However, EWM will never be completely eradicated from our lake, given the nature of its reproductive qualities. We must remain vigilant in treating it annually.

***But controlling aquatic invasive species can’t be accomplished without the funds to support chemical treatments, the Hydraulic Conveyor System (HCS) and educational campaigns such as Clean Boats Clean Waters.***

In the past, our funding strategy has included pursuing grants and donations

upcoming spring as, in some of the areas that we treated, EWM has completely gone away and not returned. Also, in most areas where we treated, the size of the infested area and just as importantly the EWM plant density level has been reduced as well. The final verdict is that we did reasonably well with our chemical treatment.

Our unique and innovative **Hydraulic Conveyor System (HCS)** underwent some substantial changes this past spring, with the upgrading of our work barge's undercarriage. This commitment to our HCS program, and to aggressively go after the new stands of EWM in our lake system, have paid real dividends: we increased the number of sites where EWM was removed by 31 percent. This technology continues to allow us to remove EWM in its earliest stages, before it mushrooms into large and dense beds that require chemical removal. With the upgrading of our system, and the continued dedication of our team, HCS results will only get better over time.

We also had significant success with our **Angel Donation** fundraising campaign and membership drive this year. Be sure to read more about the results in this newsletter.

## Our efforts to educate our members & friends

The Tomahawk Lake Association is committed to educate all those who use our watershed—shoreline owners and visitors alike—on the absolute need to be good stewards of our lake. We are always looking for new and better ways to communicate our message that every person who enjoys the lake has the responsibility to do all that they can to protect this valuable resource.

In past years, we have participated in the UW-Extension **Clean Boats Clean Waters (CBCW)** program, to bring that responsibility to the attention of lake users.

By connecting with lake users at our boat ramps, ramp attendants educate them on two fronts: with information on the Aquatic Invasive Species (AIS) that can potentially enter our lake by riding on or in boats using the ramp; and by giving free boat and trailer inspections, looking for plants and other aquatic critters that could be coming into or leaving the lake. The Clean Boats Clean Waters effort is the most direct means of education we have found to date, to get the attention of the public about the need to be good stewards.

In 2010, the TLA committed to hiring two ramp attendants to provide full coverage on weekends at two of our three ramps. They met and educated over 4,000 boats and 10,000 people over the course of the summer. In addition, **one of our attendants stopped a Zebra Mussel from entering our lake while on duty.** They worked at the thoroughfare landing and at the Lake Tomahawk landing from Memorial Day through the Labor Day, Friday afternoon to Sunday evening. This ensured that boaters using the lake during all of our peak times were inspected and made aware of their responsibility to protect our watershed. Our commitment to this program has and will continue to be our most effective means of passing good stewardship information to those who use our lake. And to stop aquatic hitchhikers from entering our watershed.

The **First Annual Tomahawk Lake Fair** was another major effort to educate the public about the enjoyment and responsibilities of the lake. Held in the town of Lake Tomahawk in early August, 60 plus volunteers and a host of presenters and exhibitors introduced hundreds of fair goers to fun ways to enjoy a day

at the lake. Speakers included noted naturalist John Bates, and WDNR fisheries biologist John Kubisiak, who gave their take on the state of the Lakeland Region's natural health. Folks had great opportunities to "see and do" many activities, from paddling a Kayak around town bay to riding on the Oneida County Fire and Rescue Teams air boat. There was plenty of

time spent trying to "stump Susan Knight", the renowned aquatic scientist from the UW Research Station at Trout Lake, and many a young fair goer had their face painted by local artists, while also learning about native plants and animals. All in all, the Tomahawk Lake Fair did more than acquaint lake area kids with what good stewardship is all



about. It also provided them and their families with a day of fun and sun with a few memories thrown in along the way.

People always want to know what's going on around them, and because of this, the Board of Directors of TLA held a **Town Hall Meeting** at the end of June at Indian Shores. While the number in attendance wasn't overwhelming, the questions and resulting discussions that took place were outstanding. The folks in attendance came away with a better understanding of what we have done, and why we have done them. The board learned first hand about the concerns of our members and friends, and all who were at the "Town Hall Meeting" came away better informed and feeling good about the future direction of our organization.

"We are encouraged by the significant reduction of acreage of EWM in 2010," said Paul Shain, President, TLA, Inc. "However, we need to continue the fight every year—it will never be completely eradicated from our lake. As a community, we need to continue executing our strategy to maintain and increase the health and beauty of Tomahawk Lake. Without our network of generous donors, volunteers and members, results like this will be impossible to achieve."

According to a survey taken in August, of the 260 sites chemically treated in May, only 57 sites contained EWM. Additionally, within the survey samples that did contain EWM, the **EWM density—the number of plants per square foot of bottom area**—fell dramatically.

The 61 treated areas ranged in size from 0.23 acres to 12.45 acres, and included a range of water depths from a few inches out to approximately 17 feet. This year, 45 new sites were added to the treatment plan compared to 2009—a 21% increase in sites treated. "The results are quite favorable, especially when one considers that the number of sites in the survey increased by 21% over 2009," said Ned Greedy, TLA Executive Director.

### Other data to note:

- In 2010, 57 of 260 points contained some EWM present in the samples taken. This represents a 78 percent reduction in EWM. In 2009, 140 of 215 points contained EWM in samples taken, which represented a 35 percent reduction in EWM.
- Within the 57 samples that contained EWM, the density of EWM plants were substantially reduced compared to 2009.
- Of the three areas targeted for treatment utilizing liquid 2,4-D, the numbers of infested sites were greatly reduced. Within the sites that retained EWM, the density was greatly reduced as well. These areas have been historically heavily infested locations. (Echo Bay, Kemps Bay & bays on south side of Windy Point.)

"While progress has been made during the summer of 2010, EWM is alive and well in Tomahawk Lake," said Greedy. "Two new major areas of infestation have been noted by our Sentinels and HCS divers and—as always is the case with this type of weed—many smaller areas have popped up."

In the early weeks of September, **Greedy and team completed the post treatment survey** to establish the treatment plan for 2011. The complete post treatment survey indicated there was minimal effect on the native species of the lake. "While we should all be proud of the progress we made this year, achieving success with EWM is a new battle every year," said Greedy. "In 2009, our treatments were not as successful. Variables such as water temperature were not on our side. To be sure, we will be faced with EWM next year and together as a community we must remain vigilant and disciplined about our efforts to fight this weed."

## Angel Giving Drive Exceeds Fundraising Goal

The great results in eradicating EWM were accomplished because donors helped TLA meet its 2010 fundraising challenge. As of October 20, the Angel Giving campaign raised a total of \$105,350, exceeding our goal of \$100,000! "Without funds, we can't accomplish our core objectives of eradicating EWM," said Paul Shain. "We are thrilled with this year's success, and grateful to our donors." "For 2011, we plan to take a different approach with fundraising that will focus on getting all households in our lake community to contribute," said Shain.

## Membership Drive Exceeds '09 Numbers; Falls Short of Goal

The TLA membership drive registered 235 members as of October 31, exceeding last year's roster of 230 members, but falling short of the 300 member goal. "The power of the TLA is made by its members," said Shain. "We look forward to working on another great campaign next year and will need everyone's help recruiting new members."

from State and local governments as well as turning to you, our membership base for monetary support. Going forward, we need to enhance this strategy.

**Here are the obstacles:** With the economic times what they are, it is clear we can no longer count on the same dollar amounts we have received from government agencies. In addition, the bulk of our private donations have come from very few people on the lake. What's more, a large number of lake residents have not contributed anything to the TLA. Long term, this is not a sustainable formula for protecting Tomahawk Lake and it puts our community at tremendous risk.

Since all of us share a love for our beautiful lake, the time has come for all of us to share in the expense of keeping it beautiful. The

value, both in economic and personal terms, of all our homes depend on a healthy and vibrant Tomahawk Lake regardless of whether or not we have EWM in front of our home today.

For 2011, the TLA will pursue a “Fair Share” fundraising campaign that will encourage every household around the lake to give a mini-

mum donation. To arrive at our suggested “Fair Share” number, we will take our 2011 budget, less what we expect from other sources (including DNR grants and local government), divided by the number of home owners on the Lake.

This fall, we will finalize our grant and town funding requests and

budget for 2011. Early next year, we will communicate our “Fair Share” request and pledge

forms to our membership base. It is reasonable to expect the “Fair Share” amount will be in the range of \$400–\$600 per household—which equates to approximately \$35–\$50 a month...much less than many of us pay for any number of modern conveniences each month. While this may seem like an uncomfortable change, please keep an open mind to the concept. We are asking everyone to contribute at an equal level.

In addition, for those interested in helping, we will be organizing neighborhood meetings across our lake community in the early summer months to educate everyone on TLA's goals, answer questions and obtain participation in the “Fair Share” program. There are many lake residents that are not familiar with TLA, so we hope this will be a perfect opportunity to introduce your neighbors to our initiatives.

### Zebra Mussel Update

Zebra mussels have been detected on Keyes Lake in Florence County, WI. Currently, no waters in Oneida County are known to contain the invasive zebra mussels; **however**, established populations are not



*Zebra mussels are a great nuisance to people. Since colonization of the Great Lakes, they have covered the undersides of docks, boats, and anchors. They have spread into streams and rivers. In some areas they completely cover the substrate, sometimes covering other freshwater mussels. They can grow so densely that they block pipelines, clogging water intakes of municipal water supplies and hydroelectric companies.*

far away. *In fact, one of our CBCW (Clean Boats Clean Waters) volunteers stopped a Zebra Mussel from entering our lake while on duty.* Early identification of any aquatic invasive species is critical to control efforts on our water body, as well as prevention efforts to protect the surrounding area. Please check your docks and lift stations this fall after removal. Mature Zebra mussels look like small

D-shaped clams. Their yellowish-brown shells have alternating light and dark stripes. Zebra mussels can reach a maximum of 2 inches in length, though most are smaller than an inch. They are typically found attached to solid objects, often

Currently, the **Minocqua and Tomahawk Thoroughfare areas have severe problems with Purple Loosestrife.** Brock Woods, WDNR Purple Loosestrife Biocontrol Program Coordinator, is looking for residents living on the water's edge close to Purple Loosestrife populations on the Minocqua-Tomahawk chain of lakes. **Brock is looking for suitable waterfront properties to place cages of biocontrol beetles.** The beetles are monophagous, which means that they feed on only one type of food, and in this case that food is Purple Loosestrife. If you have property near problematic areas of Purple Loosestrife, and you are possibly willing to allow placement of a beetle cage during a certain time period, please contact Lawrence Eslinger at 715-365-2750 or leslinger@co.oneida.wi.us.
