

LETTER FROM EXECUTIVE DIRECTOR

The Forecast Is For Sunny Skies and Warm Weather!

Question marks remain for the 2013 summer season as we find ourselves looking out our window on April 1st, at a steady wet snow pelting the 35 +/- inches of ice remaining on Tomahawk Lake. By the time that you receive this Newsletter many of those questions will have been answered, and many more will be in the process of being answered.

To be sure, the North Woods is experiencing another late spring which affects the variables that determine how we implement our Aquatic Invasive Species (AIS) control strategies for the summer. For me, the late spring is frustrating because it delays the startup of so many of the initiatives that the Tomahawk Lake Association (TLA) is involved in. Patience is most often rewarded however, and April showers (of the snow shower variety) always bring May flowers, even in Northern Wisconsin.

This summer promises to be full of both old and new activities for TLA. We will continue the fight against our old nemesis Eurasian Water Milfoil (EWM) while at the same time developing our control programs against the spread of Purple Loosestrife on our shorelines. We will continue to monitor our watershed for both old and new aquatic invasive species through our Sentinels program and our Citizens Lake Monitoring Network, and we will enhance our efforts to bring our lake community together by introducing a couple of fun and informative events aimed at every shoreline family, from the smallest kids to those of us who are maturing gracefully.

After 2012's Success Eradicating EWM, Time To "Double Down"

There is an old saying, usually attributed to wrestling coaches and political strategists that says, "When you have 'em on the mat, keep 'em on the mat!"

After the 2012 summer season, if we didn't have Eurasian Water Milfoil and Purple Loosestrife "on the mat," we certainly had 'em heading in that direction!

If you don't remember the list of accomplishments from last year, let me refresh your memories:

- **1.** Our aquatic herbicide application aimed at reducing the spread of Eurasian Water Milfoil (EWM) was highly effective, with a reduction in acreage of 70%+ of the treated "highly infested" EWM sites in the lake.
- 2. Our Hydraulic Conveyor System (HCS) removed 30,400 square surface feet of new EWM plants from 81 locations around the watershed, making a huge dent in the spread of EWM to new locations.
- **3**. Clean Boats Clean Waters ramp attendants *educated 6,700 boaters* at Tomahawk Lake's two major boat launch sites. Survey results show that 97% of those boaters were aware of the State laws which prohibit the transport of any

The total two-year control program will expend close to a quarter of a million dollars, with the state picking up roughly \$180,000 of the cost. TLA will be responsible for the remainder, with both substantial cash funding requirements and volunteer contributions.

The award of this grant represents an ongoing "vote of confidence" for the Tomahawk Lake Association in its efforts to protect and enhance our watershed. Every TLA member should feel a sense of pride in this accomplishment. Whether contributing through our "Fair Share" funding program, or by volunteering for duty in one of our many programs, you all are to be commended for taking a share of the responsibility for the wellbeing of our lake.

There are four generations of Greedy's who have—and continue to-reap rewards from the efforts of past members who stepped up to the challenges of good lake stewardship. In years to come, the children of the future will look back on TLA's efforts of today and say "They paved the way for us!"

aquatic plant material on boats, motors and trailers over the states roads. More importantly, 81% said that they had made it a routine to check their boats for aquatic plants every time that they entered or left a boat ramp. The Clean Boats Clean Waters program is working to educate and change boater's behaviors.

4. Our two programs which monitor our lake for aquatic invasive species (AIS) and warning signs in water quality performed admirably in 2012, providing data input into both TLA and the State of Wisconsin. This data helps shape our efforts to protect and enhance the quality of the Tomahawk Lake experience. The Sentinels again identified EWM site data which helped to steer our HCS divers to new infestation sites, and our Citizens Lake *Monitoring Program*, led by Jim Thompson and his highly able assistant (wife) Dee Dee, provided water quality data from several sites on Tomahawk Lake to the States water quality monitoring system.

Just a word about the Thompsons. While there are several individuals from Tomahawk Lake who have put a great deal of time & effort into the Citizens Lake Monitoring Network (CLMN), Jim & Dee Dee Thompson have worked at it for decades. Working with Sandy Wickman of the WDNR, the Thompsons have been pulling water samples and seechi disk readings (which are used to measure water transparency) from the bottom of Tomahawk for over a third of my lifetime. (I'm 63.) Each year, with no fanfare and no recognition, they just do the job. They are proud members of the Sentinels as well.

It should be noted that TLA didn't ask them to volunteer for this duty. They just began doing it. Each year TLA asks for folks to step forward and volunteer to help in one of our many initiatives. Typically, we receive volunteer help from the same people each year. I really wish that we could clone the Thompsons. I appreciate the work of all of our volunteers, but I really appreciate their loyalty.

5. Finally, 2012 was a tipping point in our *Walleye Stocking* **Program**—which is administered by the WDNR. Instead of stocking our lake with millions of walleye fry every other year, which has led to larger Small Mouth Bass, TLA persuaded the State to stock "extended growth Walleyes" (8 in.+). Last fall, 17,000 extended

growth Walleyes were placed into Tomahawk, with the intent that these fish would further grow into maturity rather than being eaten by predators. In speaking with John Kubisiak, Fishery Biologist for Oneida County, our intent is to do a second round of extended growth walleyes in the fall of 2014.

The above mentioned were things we did well in 2012. The CHALLENGE is now to follow them up with comparable or better results in 2013.

As I noted in the 2012 Fall Newsletter, "Good years are usually followed up with not so good years."

Our success in 2013 will be dependent upon several things:

- **1.** Timing of the water warming up and of our chemical application. Late spring years are extremely difficult to time right.
- **2.** Successful EWM monitoring finding and harvesting every new location of EWM infestation that we can.
- **3.** Having enough volunteers to make our other programs work to potential.

Here is our plan to make these challenges go in our favor:

- **1.** Have a second "great year" with our chemical control program.
- 2. Heavy emphasis on identifying and removing new stands with our Hydraulic Conveyor System.
- **3.** Full implementation of our <u>Purple</u> Loosestrife beetle program. (We need volunteers.)
- **4.** Focus on our Monitoring program efficiencies.

(We need 1 volunteer team.)

- **5.** Revitalize our *Clean Boats Clean Waters* volunteer effort. (We need volunteers.)
- **6.** Continue to provide entertaining & informative events for lake residents.
- **7.** Have some major FUN!

Opportunities

The TLA is an organization run by volunteers... and we need a bit more help. Take a look at some of our areas of need this summer and think about what you can do to help.

If one or more of these programs appeals to you, and you would like to learn more, please call the program coordinator to learn more.

Sentinels Aquatic Invasive Species (AIS) monitoring:

We survey 17 sectors of the Tomahawk Lake watershed twice a year, looking for aquatic invasive species, and more specifically Eurasian Water Milfoil (EWM). Each sector is surveyed twice per summer, and each of the two surveys takes roughly a half day to do.

Each team must provide a boat and a GPS (many "smart phones" have a GPS in them). The team travels through the sector looking for EWM and recording the GPS coordinates on a data sheet and/or computer spreadsheet. We provide the spreadsheet and training prior to the survey dates (late June & early August).

If you have a boat and/or a friend/spouse/ neighbor who will commit to this, it's a great way to help us identify and control EWM in the lake. We need at least one new Sentinels Team this year.

Clean Boats Clean Waters (CBCW):

We are always in need of Ramp Attendants for our CBCW program, particularly on week days. The commitment here is for one or more 4-hour work periods per summer (one a month is good). The Ramp Attendant works at one of the three boat ramps in the Tomahawk Lake Watershed. The work includes meeting boaters as they come to launch their boats. The Attendant does a quick boat, motor and trailer inspection for AIS, and then asks the boater to participate in a state sponsored informational survey (4 questions). After the survey has been completed the Attendant gives the boater a free handout which includes a lake map and a "Rules of the Road" reminder.

We provide the training, scheduling and a number of support items (tee shirt, hat, handouts). Contact Ned Greedy: (715) 358-7896 or edgreedy@gmail.com

Purple Loosestrife Control:

NEW this coming summer, TLA is building and operating a Purple Loosestrife Beetle **Propagation facility** to reproduce and grow Purple Loosestrife Beetles which eat the Purple Loosestrife plant.

We will be asking for volunteers to help build the facility, and to collect plants to use in the "birthing" areas of the facility. Then when the "beetle babies" are ready, we will need volunteers to go out into the watershed and stock the beetles in the areas where Loosestrife infestations exist.

If you're good with a hammer and saw or if you like going around the lake releasing bugs onto plants, this program could be for you. We are

Orange Barrel Season

Yes, it is orange barrel season in Minocqua! The construction of Hwy. 51 North has begun. It will consist of:

- Replacing the current five-lane cross-section with new asphalt pavement and curb and gutter.
- Enhance pedestrian and bicycle accommodations via a wider outside travel lane for on-street bike users as well as a wider sidewalk. The enhanced accommodations include areas along Lake Minocqua, where pedestrians can rest and enjoy the view.
- A HAWK (High-Intensity Activated crossWalK) crosswalk will be installed a block north of Save More Grocery. The HAWK crosswalk is a pedestrian hybrid beacon overhead signal activated by the pedestrian to stop traffic for a timed duration.
- New street lighting will provide continuous lighting along the corridor.
- Storm, sanitary and water lines will be replaced. This effort will also improve the storm water quality discharging into the lake. MKLPA (Minocqua-Kawaguesaga Lake Protection Association) has been very active in this effort.

Invasives Hitch Rides with **Boaters**...*Not Birds*

When it comes to moving in to Wisconsin lakes, aquatic invasive species have a preferred mode of transport – one that often involves an outboard motor.

Five Year Study Explores Spread and Distribution of Invasives

Scientists at the UW-Madison Center for Limnology (CFL) and the Wisconsin Department of Natural Resources (WDNR) are in the middle of a five year study exploring the spread and distribution of exotic plants and animals into our inland lakes. They've discovered that natural dispersal mechanisms, like birds carrying invasives in beaks or bellies, can't explain the patterns they're seeing. Only human intervention makes the maps make sense.

"None of the wilderness lakes we surveyed had invasive species in them," says Alex Latzka, a graduate student in the Jake Vander Zanden lab at the CFL. "But, 30 percent of the lakes we looked at that had human development, like nearby roads, shoreline homes and boat ramps, had at least one invasive species present."



Although iconic images of northern Wisconsin, invasive species aren't much of a threat to isolated "wilderness" lakes.

Monitoring 450 Lakes

The CFL and WDNR are monitoring 450 lakes in Wisconsin, hoping that uncovering trends in invasive species dispersal will allow them to better direct their time (and funds) toward protecting lakes that currently boast only native species but will likely face pressure from invasives in the future.

"People often think that the lakes that are the most worthy of our protection and most susceptible to invasion are the pristine wilderness lakes," Latzka says. "While those kinds of lakes are iconic in the Wisconsin Northwoods, they're not the lakes most vulnerable to invasive species."

Problematic Exotic Species

And there's also a lot of variability among lakes with signs of human development. For example, only 30% of lakes with public access had

Eurasian water milfoil, a prolific exotic plant, and fewer than 20% of lakes had zebra mussels, despite both invasives being problematic exotic species that have thrived in the state for decades.

By getting to the bottom of differences like these and getting high risk lakes on the map, Latzka and researchers at the WDNR and CFL hope to better predict and, ideally, prevent invasive species introductions in the future.

Outreach Specialist

Adam Hinterthuer is the outreach specialist for the Center for Limnology and the University of Wisconsin-Madison. He is also director of programs for the Institutes for Journalism and Natural Resources. He lives in Madison with his wife and two daughters, who enjoy exploring Wisconsin's lakes with him. They even think the family owns a cabin "up North," thanks to frequent visits to the Center for Limnology's Trout Lake Station!

Citizens Lake Monitoring Network:

The "Citizens Lake Monitoring Network" is a lake monitoring effort that samples water quality in Tomahawk Lake by collecting and analyzing water samples at specific locations within the watershed. This program examines water chemistry and performs specific water tests to ensure that the lake is not out of chemical balance. Water Samples are collected through out each spring, summer and fall, with the sample results being sent to the State. We need volunteers to help us with this effort at all of these times, but volunteers can commit to just a part of the season as well.
